It is proposed to perforate and fracture an additional pay in the
subject well using the following procedures:

1. Test for casing hole.
2. Squeeze portion of existing perforations from 5,946 to 5,980'.
3. Frac remaining perforations 5,898 to 5,934 with 120,000 gallons lease crude.
4. Perforate 5,837, 5,842, 5,848, 5,853, 5,866, and 5,871, and acidize with 10,500 gallons retard acid. Test.
5. Complete well by opening off perforations to production.

A subsequent report of operations will be submitted upon completion.
