It is intended to drill a well at the above location with rotary tools to an approximate total depth of 6100' in the Blinebry formation. Casing will be set in accordance with USGS regulations and other special requirements will be complied with.

The following casing pattern is planned: 7-5/8" OD 24# J-55 set at 1300' with 400 sacks cement; cement to circulate. 4-1/2" OD 9.5# and 11.6# J-55 set at 6100' with 300 sacks cement; cement to return to 2400'.

Permission to produce this well upon completion is also requested.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.

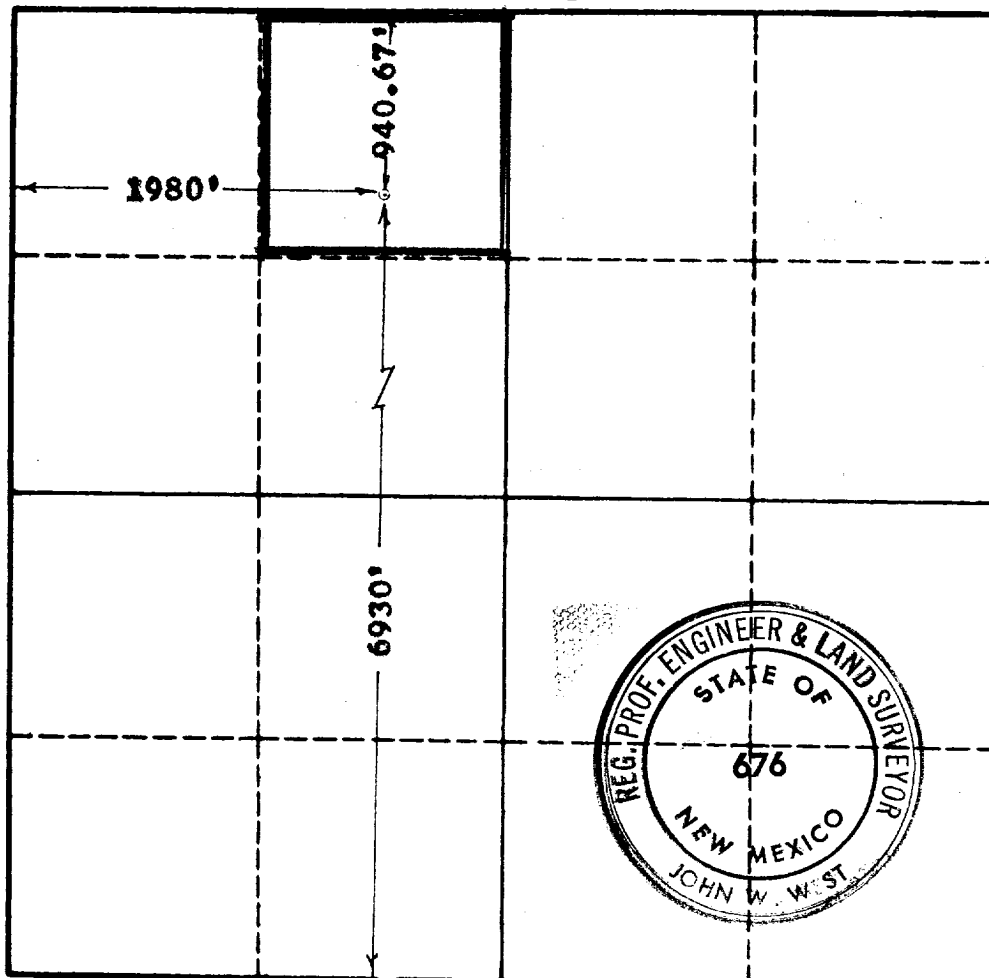
