## DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Acidized thru 2-3/8" tubing w/2000 gallons 15% low tension acid by Chemical Process. TP vacuum, CP vacuum. Average injection rate 91 GPM, bled 15 bbls water. Displaced w/15 b 1s water. Injection time 22 minutes, duration time 52 minutes.

<u>RESULTS:</u> Initial flowed no cil, 197 bbls water thru 2-3/8" tubing WO in 24 hrs ending 15th. Formation gas volume, none. Formation GOR, no cil produced. Input gas volume 380,568 cu.ft. Input GOR 1932/1. Allowable None. Daily average production before workover 3 bbls cil, 17 bbls water for April, 1952. Allowable before workover 3 bbls exempt.
