Installed Cabot AC 15E 114D w/25 HP Electric Motor. Ran 125 jts. 3881' tubing. Tubing set at 3887', seating nipple at 3870', perf 3872-76'. Ran Pump & Rods.

RESULTS: Pumped on Oil Conservation Commission test 60 bbls. oil, 12 bbls. water thru 2-3/8" tubing in 24 hrs., 16 x 54" spm. Gas volume 35,700 cu. ft. GOR 595. Allowable before equipment replacement 12 BOPD. Allowable after equipment replacement 45 BOPD.
