Installed Cabot AC 115 E 114 D w/25 HP Electric Motor. Ran 121 jts. 3825' tubing. Tubing set at 3829', seating nipple at 3813'. Ran pump & rods.

Pumped on Oil Conservation Commission test 52 bbls. oil, 56 bbls. water thru 2-3/8" tubing in 24 hours, 16 x 54" spm. Gas Volume 70,400 cu. ft. GOR 1354. Allowable before equipment replacement 9 BOPD. Allowable after equipment replacement 45 BOPD.
