Acidized with 4000 gals 15% HCL NE acid in 2 stages using 6 rubber coated nylon ball sealers. Flushed with oil. Swabbed and recovered load oil. Ran rods and pump and placed well on production.

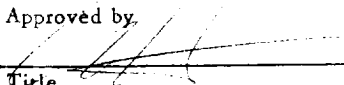
