

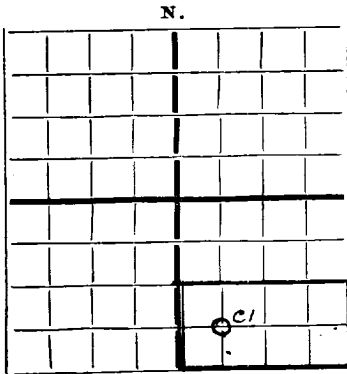

 The "Squeeze Job" will be used to cement off the gas formation prior to running the 7" casing.**
