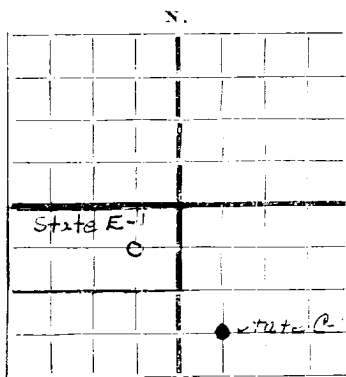

If changes in the above plan become advisable we will notify you before cementing or landing casing. We estimate that the first productive oil or gas sand should occur at a depth of about **5900** feet. Additional information:

Sufficient cement will be used back of the 10 3/4 to bring the cement back to the surface.

The "Squeeze Job" will be used to cement off the gas formation prior to running the 7" casing.
