In order to return well to production it is proposed to fracture treat as follows:

1. Pull tubing. Clean out with sand pump if necessary.
2. Run 2-7/8" tubing with formation packer set at approximately 3800'.
3. Treat formation below packer with 10,000 gallons gelled lease oil with 1# sand per gallon.
4. Pull 2-7/8" tubing and packer. Run 2-3/8" tubing and return well to production.
