Gentlemen: Following is a notice of intention to do certain work as described below at the Gulf Oil Corp - GYPSY PROD DIVN - Orcutt C State Well No. in Company or Operator of Sec. 5, T. 218, R. 36E, N. M. P. M., Hunice Field,County. FULL DETAILS OF PROPOSED PLAN OF WORK FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS OF THE COMMISSION Authority is requested to produce eight wells on our Orcutt State "C" lease, located in the Eunice Pool, in a Central tank battery. At the present time this lease has a split royalty and is carried as North 80 acres wells # 5 and 7, and South 240 wells 1, 2, 3, 4, 6 and 8. The North 80 Acres, wells #5 and 7 are produced into two 22' x 10' tanks. The South 240, wells 1, 2, 3, 4, 6 and 8 are produced into a battery consisting of five - 16' x 10' and one 22' x 10 tenks, with a treating system. It will soon be necessary to treat the oil from the North 80 wells 5 and 7. Tankage for the South 840 and North 80 are in the same battery, the battery is split as outlined above. To eliminate the necessity of erecting a treating system to care for the North 80 wells # 5 and 7 we propose consolidate these two batteries and handle all eight wells through one treating system This proposed change will provide adequate facilities and storage to take care of any testing which is to be done for each well. Separators and headers are so located that these tests may be made. Under date of July 3, 1942 the New Mexico Tax Commission authorized the consolidation of the two batteries.
