Gentlemen:

Gulf Cil Corporation hereby makes application for approval of a nonstandard gas prevation unit comprising Lots 1, 2, 3, 4, 5, 6, 7, and 8, of Section 6, T-21-S, R-36-E, Lee County, New Mexico, and in support thereof states the following facts:

- (1) Gulf Oil Corporation is owner and operator of an oil and gas lease known as its H. T. Orcutt "C" Lease located in Lots 1, 2, 3, 6, 7, and 8 of Section 6, T-21-S, R-36-E, Lea County, New Mexico. The Atlantic Refining Company is owner and operator of an oil and gas lease located in Lots 4 and 5 of Section 6, T-21-S, R-36-E, Lea County, New Mexico. The Gulf and Atlantic leases comprise the 304.83 acres above described.
- (2) Gulf Oil Corporation proposes that the above described acreage be designated as a non-standard 304.83-acre gas provation unit in exception to Rule 5(a) of Order R-520.
- (3) Gulf (il Corporation's H. T. Oreutt "C" Well No. 8 located 1980 feet from the east line and 660 feet from the north line of Section 6, T-21-S, R-36-E, Lee County, New Mexico, was dually completed on November 8, 1955. Oil will be produced from the Pearese section of the Queen Formation and the gas-well gas will be produced from the Knight section of the Queen Formation. Applicant requests that the above described 304.83 acres be ascribed to this well for provation purposes.
- (4) Contingent upon obtaining Conservation Commission approval of this application for the non-standard 304.83 acre gas provation unit, Gulf Oil Corporation and The Atlantic Refining Company have agreed to enter into a gas pooling agreement and an operating agreement covering the above described 304.83 acres for
