DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

12 1/2" 40# 8-thd. New Lapweld casing was set in this well at 232' and cemented by the Halliburton Method with 265 sacks.

Casing was drilled out and the hole was then bailed dry and allowed to stand for one hour undisturbed. The bailer was then run to bottom again to determine if any water had accumulated. No water had accumulated so the drilling was then resumed.
