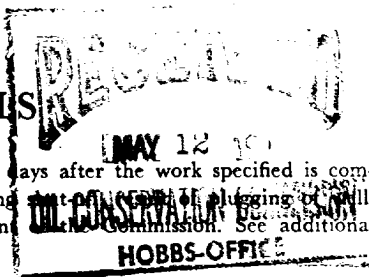

DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Installed Cabot AC 15E 114D Unit with 25 HP Electric Motor. Ran 129 jts. 2-3/8" tubing. Set at 3922', seating nipple 3906', perforations 3908' to 3912'. Ran pump & rods.

Pumped on Oil Conservation Commission test 70 bbls. of oil, 4 bbls of water through 2-3/8" tubing in 24 hours, 16 x 54" spm. Formation gas volume 51,119 cubic feet. GOR 730/1. Average daily production for March 30 bbls. of oil, 9 bbls. of water. Allowable before equipment replacement 35 bbls. per day. Allowable after equipment replacement 45 bbls. per day.
