Installed Cabot AC 15E 114 D w/25 HP Electric Motor. Ran 123 jts. 3901' Tubing. Tubing set at 3906', seating nipple at 3890', perf 3891-95'. Ran Pump & Rods.

RESULTS: Pumped on Oil Conservation Commission test 28 bbls. oil, 42 bbls. water thru 2-3/8" tubing in 24 hrs, 15 x 54" spm. Gas Volume 161,900 cu. ft. GOR 5782. Allowable before equipment replacement 6 BOPD. Allowable after equipment replacement 28 BOPD.
