Installed Cabot AC 115E 114D PU w/25 HP Electric Motor. Ran 128 jts. 3861' Tubing. Tubing set at 3861', seating nipple at 3845', Perf. at 3846-50'. Ran pump & rods.

RESULTS: Pumped on Oil Conservation Commission test 70 bbls oil 9 bbls water thru 2-3/8" tubing in 24 hrs. 14 x 54" spm. Gas volume 184,400 cu. ft. GOR 2634. Allowable before equipment replacement 24 BOPD. Allowable after equipment replacement 45 BOPD.
