Set CI BP at 3704'. Loaded 4-1/2" casing with 52 barrels of 9.2# brine containing 25# salt gel clay per barrel of water. Tested casing and BP with 400#, 30 minutes, OK. Spotted 3 sack, 38' of Class H cement plug on top of BP at 3704' to 3666'; 8 sack, 108' cement plug from 1338' to 1441', across top of salt and 3 sack plug from 51' to surface. Installed dry hole marker. Plugged and abandoned May 15, 1975. Will advise when location is ready for inspection.
