Pumped on Oil Conservation test 20 bbls. oil, 46 bbls. water thru 2-3/8" tubing in 24 hrs, 14 x 54" spm. Gas Volume 24,200 cu. ft. GOR 1210. Allowable before equipment replacement 10 BOPD. Allowable after equipment replacement 20 BOPD.
