FULL DETAILS OF PROPOSED PLAN OF WORK
(FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)

1. Fish out packer and tubing.
 2. Clean out to total depth.
 3. Run caliper survey of open hole and radioactivity log from surface to total depth.
 4. Selectively fracture open hole with 10,000 gallons refined oil and 10,000 pounds sand in two stages with 600 pounds moth balls between stages.
 5. Place well back on production.
- Producing Interval: Open hole from 3762 to 3885.
Current test: 24 hours pumping, 15 barrels oil, 2% water, GOR 8675.
