Re: Application for Nonstandard Gas
Proration Unit in the Sumont Gas
Pool to be assigned to Sinclair's
M. S. Berryman Well No. 1.

Gentlemen:

Sinclair Oil & Gas Company makes this application for an Administrative Order under Order R-520 which will establish a 40 acre Nonstandard Gas Proration Unit in the Sumont Gas Pool to be assigned to Sinclair's M. S. Berryman Well No. 1.

In this connection Sinclair wishes to state:

1. Sinclair is the operator of the M. S. Berryman Well No. 1 which is located in the SW SE of Section 11-21S-36E, Lea County, New Mexico. This well was originally completed August 28, 1936 as an oil well in the Sumont Oil Pool and was plugged back and recompleted in the Sumont Gas Pool on March 16, 1956 with an indicated open flow potential of 1600 MCF per day.
2. The proposed nonstandard unit consists of Sinclair's M. S. Berryman Lease and occupies the SW SE of said Section 11. Sinclair's M. S. Berryman Well No. 1 is located 330 feet from the South line and 330 feet from the East line of this proposed unit thus qualifying for a 40 acre administrative assignment.
3. The length or width of the proposed unit does not exceed 5280 feet.
4. The proposed unit consists of a quarter-quarter section and lies wholly within a single governmental section.
5. The entire proposed unit may reasonably be presumed to be productive of gas.
6. The leasehold interests and the royalty interests are common under this proposed unit.

7. All offset operators as defined in Order R-520 have been notified of this application by copy thereof via registered mail. Said operators are listed below.

Sinclair believes that the granting of this application is in the interest of conservation and the protection of correlative rights. Sinclair, therefore, requests that an Administrative Order be issued for the purpose of granting this application.

I hereby certify that the information contained in this application is true and complete to the best of my knowledge and belief.
