Propose to plug off **Bunice** Oil pay and recomplete as gas well in the **Bumont** pay as follows:

1. Pull tubing.
2. Run radioactivity log with collar locator.
3. Set cement retainer at 3675' and squeeze cement the open hole interval (3682-3880').
4. Perforate gas zone with 4. 1/2" JHPF (interval based on results of radioactivity log).
5. Run tubing, swab and test.
6. Hydraulically fracture with 10,000 gallons sand and oil if warranted.
