Deepened from 3865' to 3955'. Ran GR/CCL/CNL/Caliper logs. Acidized with 4000 gallons 15% NEFE HCL. Equipped for injection with 2 3/8" IPC tubing and packer set @ 3647'. Tested casing and packer to 600 psi for 30 minutes (OK). Returned to production as an injector. Work performed 2/5/87 - 2/9/87.
