DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

July 17, 1936 well was spudded and drilled to depth of 15' in sand. 7-18-36 well was drilled to depth of 330' in redbed and 10-3/4" OD casing was set and cemented with 200 sacks at 327'.

After cement had been allowed to set 48 hours plugg was drilled, hole bailed dry and allowed to set 2 hours and again tested dry.
