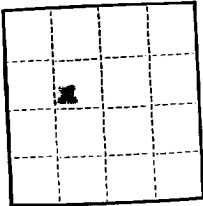

DETAILS OF WORK

Remedial work performed during October, 1957 and offset information definitely establish the original open hole completion zone as being completely watered out. No possibilities for recompletion exist and all recoverable oil reserves have been depleted.

Permission is requested to plug and abandon the subject well in the following manner:

1. Load hole with mud.
 2. Set 20 sacks cement plug at 3800'.
 3. Set 10 sacks cement plug at surface and erect marker.
 4. Clean and clear location.
- All casing will be left in hole.

A subsequent report will be filed upon completion of this work.
I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.
