Completed 6/5/34, swabbed clean of drilling fluid but would not flow, treated with 1000-gallons of Dowell XX Acid, ran swab eight times to start flowing, after cleaning produced at the rate of 972-bbls for 24-hours thru tubing, would not flow thru casing, less than million feet gas.

Time treating: Well dead.

Used 35-bbls oil before acid and 35-bbls after acid.

Tubing or casing did'nt show any pressure until last 15 minutes of pumping oil after acid, tubing built up to 200# and casin 250#
