**DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED**

On 10/23/35 treated with 3000 gals. Dowell XX solution, (1530 gals. 23% HCl, 1470 gals. water, 7½ gals. Muridine (Inhibitor) and 252 # Dowell Intensifier) pumped in thru 3954' of 1½" U. E. tubing, perforated from 3950 to 3952' by Dowell, Inc. Acid preceded by 33 bbls. oil pumped in thru tubing to kill well and followed by 38 bbls. oil to flush acid out of tubing and force it into formation. Steed 17½ hours for acid to react. Made 291 bbls. oil and 132 MCF gas in 1 hour thru ½" line from casing. No flow thru tubing. Casing pressure 90# throughout test.

Figure 1. The effect of the concentration of the *Agrobacterium* suspension on the transformation efficiency of *Agrobacterium* strains. The *Agrobacterium* strains were grown in the medium containing 100 mg/l of tetracycline. The cells were harvested at the stationary phase of growth and adjusted to the concentration of  $10^8$  cells/ml. The cells were then mixed with the plasmid solution and the mixture was used for the transformation of *Agrobacterium* strains. The transformation efficiency was determined by the number of transformants per  $10^8$  cells. The results are shown as the mean  $\pm$  SD of three independent experiments.

1. *Chlorophyll a* and *b* were determined by the method of Lichtenthal and Whistler (1973). The total chlorophyll content was determined by the method of Arar and Cook (1977).
