## DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Installed Oil Well 46G21 Unit w/40 HP electric motor. Ran 124 joints 3880' of 2-3/8" tubing. Tubing set at 3885', standing valve 3873', perforations 3874-3876'. Ran pump and rods.

RESULTS: Pumped on Oil Conservation Commission Test 55 bbls oil 164 bbls water thru tubing in 24 hours, 21 x 72" SPM. Formation gas volume 46,560 cu.ft. GOR 847/1. Average daily production for December 1952 14 bbls oil 165 bbls water per day. Allowable before installing pumping equipment 15 bopd. Allowable after installing pumping equipment 45 bopd.
