DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Installed Oil Well 46G21 pumping unit w/40 HP electric motor. Ran 123 joints 3879.55' of 2-3/8" tubing. Tubing set at 3884.55', standing valve 3872.55', perforations 3873-3875'. Ran rods and tubing.

RESULTS: Pumped on Oil Conservation Commission test 50 bbls oil, 367 bbls water thru tubing in 24 hours, 21-72" SPM. Formation gas volume 78,460 cu.ft. GOR 1569/1. Average daily production for January 1953 34 bbls oil, 368 bbls water per day. Allowable before installing pumping unit 35 bopd. Allowable after installing pumping unit 45 bopd.
