DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Installed Cabot ACL3E114D pumping unit w/15 HP electric motor. Ran 124 joints 3891.81' of 2-3/8" tubing. Tubing set at 3897.81', seating nipple at 3883.70', perforations 3884-3886'. Ran pump and rods.

RESULTS: Pumped on Oil Conservation Commission test 57 bbls oil 15 bbls water thru tubing in 24 hours, 17 x 48" SPM. Formation Gas volume 27,800 cu.ft. GOR 487/1. Average daily production for December 1952 14 bbls oil 3 bbls water. Allowable before installing pumping equipment 10 bopd. Allowable after installing pumping equipment 45 bopd.
