FULL DETAILS OF PROPOSED PLAN OF WORK

FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS OF THE COMMISSION

It is proposed to place the above well on Gaslift. This well was placed on production March 1st, and a test prior to placing well on production showed it to make 82 bbls. in 6 hours, with 466,000 cu.ft. of gas, cutting 50% water. An attempt was made to plug off the water with cement. After the well flowed for a time, it went dead. It is our plan to obtain gas from our W. A. Ramsay gas well which is on state land and is located in the SW Corner of Sec. 34-21-36. Since the well will build up to 900 lbs. on the casing, very little gas will be needed to flow the well continuously. It is difficult to state what the gas-oil ratio or gas-fluid ratio will be, but we can assure you that the well will not produced with high gas-oil or gas-fluid ratio. Immediately after testing this well a we wish to place this well on gaslift immediately. Gas will be metered to the well daily
