FULL DETAILS OF PROPOSED PLAN OF WORK
(FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)

In order to increase production it is proposed to fracture treat as follows:

1. Pull 2-3/8" tubing.
2. Run 2-7/8" tubing with Hookwall packer and hydraulic holddown. Set packer in base of 5-1/2" casing at 3710'.
3. Treat with 8,000 gallons gelled lease oil with 1# sand per gallon.
4. Pulled 2-7/8" tubing, packer and holddown, rerun 2-3/8" tubing.
5. Swab and test.
