Fracture through perforations from 3820 to 3856 feet with 20,000 gallons refined oil and 20,000 pounds sand in two (2) equal stages. Between stages inject 40 rubber balls. If there is no indication of perforation plugging, pump in 600 pounds crushed moth balls.

Current Producing Interval: Perforated casing from 3820 to 3856.
 Latest Test: 24 Hours, Pumping, 1,055 Bbls. oil, No Water, GOR 4306.
