Oct 21st 1937 the 5 1/2" casing was cemented in Lime at 3658' with 150 sacks cement by the Halliburton Cementing Process.

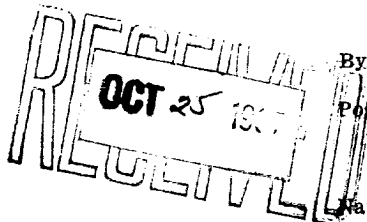
