FULL DETAILS OF PROPOSED PLAN OF WORK
(FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)

1. Move in and pull tubing and run water locator survey.
2. Clean out well to total depth and run and cement liner.
3. Perforate for production based on results of water locator survey and radioactivity logs.
4. Stimulate well as necessary to obtain a well capable of producing oil at top allowable rates.
