FULL DETAILS OF PROPOSED PLAN OF WORK

1. Pull tubing. Clean out to TD (3863).
2. Run open hole caliper and radioactivity log.
3. Frac open hole with 15,000 gals. refined oil and 15,000 pounds sand. (Interval to be stimulated will be determined from log.)
4. Place well back on production.

Current producing interval: Open hole from 3825 to 3863.

Current test: 24 hours, pumping, 6 bbls. oil, 4% water, GOR 19,863.
