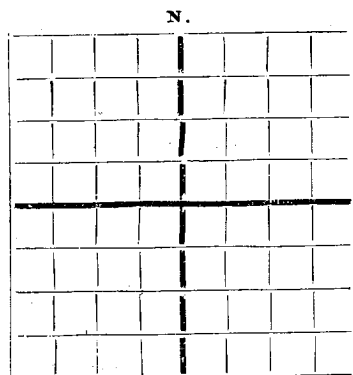

## NOTICE OF INTENTION TO DRILL NEW WELL

Notice must be given to the State Geologist or to the proper Oil and Gas Inspector and approval obtained before drilling begins. If changes in the proposed plan are considered advisable a copy of this notice showing such changes will be returned to the sender. Submit this notice in triplicate. One copy will be returned following approval.

If changes in the above plan become advisable we will notify you before cementing or landing casing. We estimate that the first productive oil or gas sand should occur at a depth of about **3868** feet **al-** though gas may occur at any depth below the top of the brown line which is **expected at approximately 3128 feet.**

Oil pay expected at about **3942** feet.
