We propose to plug subject well as follows:

1. Mud up hole and circulate.
2. Pull all recoverable 7" casing and run tubing and spot cement plug.
3. Spot 38 sx plug over perfs from 3400' to 3570', move up hole and spot 120 sx plug from 1520' to 1400' (approximately 60 sx in top unrecoverable 7-inch and 60 sx in 9-5/8" casing)
4. Spot 25 sx plug at surface and set steel 4' marker above ground level.
