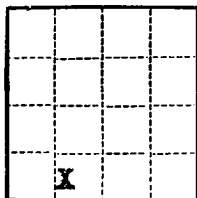

DETAILS OF WORK

Washed over pipe to top of packer hanger at 3559'. Socket parted while jarring on packer hanger, leaving 18" of 4-11/16" OD socket on top of packer hanger. Top of packer hanger 3559'. Top of 2" tubing 3440'. Ran radioactivity log. This well is presently shut in pending study for possible remedial work.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.
