Detailed account of work done, nature and quantity of materials used, and results obtained.

We killed well with lease crude, perforated by cutting one notch with Dowell Abrasijet at 3882 feet. Then we fracture treated using 40,000 gallons of refined oil and 99,000 pounds of 20-40 fracs sand. The upper perforations had been treated with 750 gallons of Dowell ~~XXXXXX~~ Jolex 820 so as to be blocked during and immediately after the perforating and fracturing. All frac material is assumed to have been injected at 2882'.


