Gentlemen:

Gulf Oil Corporation respectfully requests an exception to Rule 5(A) of Order R-1670 for approval of an 80-acre Non-Standard Gas Proration Unit covering the N/2 SE/4 of Section 32, Township 21 South, Range 36 East, Eumont Gas Pool, Lea County, New Mexico. This Non-Standard Unit will be attributed to the J. F. Janda (NUT-B) Well No. 1, located 1980 feet from the south line and 1980 feet from the east line of this Section 32.

In support of this application, the following facts are submitted:

- (1) Applicant's J. F. Janda (NUT-B) Well No. 1 is now assigned a 160-acre Non-Standard Gas Proration Unit covering the SE/4 of Section 32.
- (2) Applicant desires to reduce the acreage attributed to this well to 80 acres covering the N/2 SE/4 of Section 32.
- (3) The Non-Standard Unit consists of contiguous quarter-quarter sections.
- (4) The Non-Standard Unit lies wholly within a single governmental section.
- (5) The entire Non-Standard Unit may reasonably be presumed to be gas productive in the Eumont Gas Pool.
- (6) The length or width does not exceed 5,280 feet.

All operators owning interests in the section in which the Non-Standard Gas Proration Unit is located and all operators within 1500 feet of the unit well have been furnished a copy of this application.
