BP. Pulled 2-3/8" tubing and BP. Cleaned out with 3-1/2" sand pump from 3850' to 3875'. Ran 2-3/8" tubing, Baker Model "C" FB packer and parallel anchor on 2-1/16" tubing (Long String) and set in tension with 16,000#. Ran 2-1/16" tubing (Short String) with Baker stinger sub on bottom and latched into parallel anchor and set in tension with 10,000#. Ran rods and pump in South Eunice. Placed both zones on production.
