2. Set bridge plug on electric line at approximately 3765'. Dump 1 sack cement on plug.
3. Set cement retainer on tubing at 2700' and squeeze cement below retainer. Drill out retainer and cement; drill out bridge plug and cement to 3830'.
4. Run tubing with packer and return well to production.
