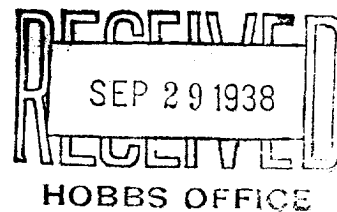

TD-1620'. On Sept. 23 ran 71 joints of 7 5/8" OD 26.4# 8 thread second hand SC LW St. Casing, set at 1611'7", Casing was cemented in anhydrite with 600 sacks 4% aquagel and 50 sacks of neat cement, plug was pumped to 1583'. Cement did not circulate in cellar. Dumped 3 more sacks cement back of casing which filled to top, making a total of 653 sacks used on string.

Propose to drill plug and test casing shut-off at 930 PM Sept. 25th.
