FULL DETAILS OF PROPOSED PLAN OF WORK
(FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)

In order to increase production, it is proposed to perforate 5-1/2" casing and fracture treat as follows:

1. Pull tubing.
2. Perforate 5-1/2" casing from 3838-3851' with 4, 1/2" jet holes per foot. Run 2-7/8" tubing with packer. Treat formation thru perforations in 5-1/2" casing with 10,000 gallons gelled lease oil with 1# sand per gallon. Pull tubing and packer.
3. Run tubing and return well to production.
