FULL DETAILS OF PROPOSED PLAN OF WORK
(FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)

Prepare as producing well in water-flood project as follows:

1. Deepen to 3950'.
2. Run GR-N and ES-Induction logs.
3. Perforate with 4, 1/2" JHPF from 3726-32', 3816-22' & 3828-34'.
4. If necessary, plug back as directed (5 to 20').
5. Straddle zones in open hole as directed, acidize each zone with 1500 gals 15% NE acid.
6. Straddle each set of perfs in step 3 and acidize with 1500 gallons 15% NE acid.
7. Equip as producer in flood.
