Prepare as water injection well in pilot water flood as follows:

1. Deepen to 3960'.
2. Run GR-N, ES-Induction logs.
3. Perf with 4, 1/2" JHFF from 3810-20', 3791-95', 3744-48' & 3730-34'.
4. If necessary, plug back as directed (from 5 to 20')
5. Selectively acidize each interval as directed with 1500 gals 15% NE acid each.
6. Equip as water injection well.
