1. Deepen to 3955'.
2. Run GR-N log.
3. Perf with four 1/2" JHPF from 3768-75'.
4. If necessary, Plug back as directed (approx. 10').
5. Straddle zones in open hole as directed and acidize with 1500 gals 15% NE acid.
6. Straddle perfs in Step No. 3 and acidize with 1500 gals 15% NE acid.
7. Equip as producer.
