DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Installed Cabot AC 13E-114D unit w/15 HP electric motor. Ran 125 joints 3838' of 2-3/8" tubing. Tubing set at 3844', seating nipple at 3836', perforations 3838' to 3840'. Ran pump and rods.

RESULTS: Pumped on Oil Conservation Commission Test 46 bbls oil 5 bbls water thru tubing in 24 hours, 13 x 48" SPM. Formation gas volume 50,400 cu.ft. GOR 1095/1. Average daily production for January 1953 no oil, no water. Allowable before installing pumping equipment none. Allowable after installing pumping equipment 45 bopd.
