DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

This well was spudded 3-29-54. A 17 1/2" hole was drilled to 212' and 13-3/8" 40# new casing was cemented at 208' with 240 sacks. Cement was circulated to the surface. The casing and cement job was tested with 500 psi for 30 minutes and found to be ok. Cement was allowed to set 24 hours before resuming drilling operations.
