## DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Ran 98 Jts and piece (3083') 8-5/8" OD 32# Gr H-40 and J-55 SS casing. Set and cemented at 3099' with 1875 sacks 4% Gel and 150 sacks Neat on bottom. Plug at 3066'. Maximum pressure 1100#. Circulated approximately 75 sacks cement. Job complete 8:30PM 8-6-54.

After waiting over 30 hours, tested 8-5/8" casing with 1000# for 30 minutes. There was no drop in pressure. Drilled cement plug from 3066' to 3099' and tested below casing shoe with 800# for 30 minutes. There was no drop in pressure.
