DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Ran 187 Jts and cut jt (5875') 5-1/2" OD 15.50# and 14# Gr J-55 SS casing. Set and cemented at 5889' with 625 sacks 45 Gal and 150 sacks Neat on bottom. Plug at 5804'. Maximum pressure 1700#. Job complete by Noon 6:PM 10-22-54.

After waiting over 30 hours, tested 5-1/2" casing with 1800# for 30 minutes. There was no drop in pressure. Drilled cement plug from 5804' to 5889'. Tested below casing shoe with 1800# for 30 minutes. No drop in pressure.
